ABOUT CFNCF

The Community Foundation of North Central Florida is about philanthropy and helping individuals fulfill passions and missions. We do that by making it possible for donors of all kinds to participate in creating permanent funds to meet current and future needs.

BY THE NUMBERS

Founded in 1998 by the North Central Florida Estate Planning Council to fill a need in the community.

As of 2018 the CFNCF houses 110 funds totaling more than \$20M in assets.

In 2017 alone the CFNCF awarded \$3.5M in grants to our local community.

The Center for Nonprofit Excellence was launched at the CFNCF in 2015 and currently serves more than 50 local nonprofits.

The Women's Giving Circle is celebrating 10 years of collective giving in 2016, with more than 200 women having given \$700,000 in grants to 26 organizations.

The mission of the Community Foundation of North Central Florida is to promote and sustain philanthropy among the communities of North Central Florida.
